1. Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, because only some residual work remains with respect to an evaluation work of the Elan project stated in the previous year. In addition, further streamlining of costs was implemented. This will have the effect of a substantial reduction of cash outflows in the next two quarters. The Company will continue to focus on stakeholder consultation.

2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: In addition to streamlining costs within the organisation, the Company received subsequent to the quarter end, an amount of \$1,490,752, representing the balance of net proceeds from the entitlement issue.

Answer: Based on forecast expenditure and available cash (including the funds received as mentioned in 2. above, the Company expects to be able to continue its operations and meet its revised business objectives.
