- Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

Answer: No, because the Company has halted its drilling programme and paused PFS studies. Expenditures are expected to be substantially lower in the next quarter. During the current quarter, a significant amount of cash has been utilised to pay for expenses incurred in the first quarter with respect to PFS and environmental studies. With the announcement of the reinstatement of the Coal Policy in Alberta, work on PFS has been paused and environmental baseline studies streamlined significantly whilst ensuring continuity of data collection to previous years. This will have the effect of a substantial reduction of cash outflows in the next two quarters, as the Company focusses on stakeholder consultation. The Company has sufficient cash to attend to its cash requirements for the next two quarters.

- Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

Answer: The Company continues to review its cash position and outlook in light of revised business objectives and forecast activity over the coming quarters. The market will be advised if any steps are proposed to raise further cash.
